- Vehicles are not allowed in Christmas tree fields under any circumstances. All props, furniture, etc. must be carried to your photoshoot location. We recommend bringing a wagon to transport props or other items.
- All props must be removed upon departure.*
- All professional sessions MUST have a prior appointment.

GUIDELINES AND WHAT TO EXPECT FOR YOUR SESSION

- All photography performed at Spring Creek Growers must have written consent by the owners or owners' representative prior to photos being taken. **Appointments must be made in advance.**
- Spring Creek Growers is a fully-operating farmstead. Please take into consideration weather and the natural environment as you and your clients prepare for your visit with us. Boots or close-toed shoes are highly recommended. Dress for the weather!
- The photography fee charged during available photography dates is **\$100 per day**. This fee must be paid directly from the photographer to Spring Creek Growers. This fee must be paid upon arrival **before** the beginning of the booked session.
- We ask that all children under 12 years of age be accompanied by an adult at all times.
- Spring Creek Growers reserves the right to prohibit any business disruptions to daily operations or to regular customers due to photography sessions. If any fixed or temporary objects are moved or damaged during photography, the photographer will be held responsible for replacement and/or payment. Spring Creek Growers also reserves the right to prohibit inappropriate attire on premises at any time.
- No professional Santa Claus characters may be onsite while Spring Creek Growers' designated Santa Claus is onsite for visiting and photography hours. These hours are listed on the website and are subject to change at any time. Please call to make arrangements with the office if you would like to photograph a professional Santa Claus.
- The photographer and all photographer's clients will hold harmless Spring Creek Growers for any injuries sustained during photography sessions and is not responsible for injuries that may occur from poses or requests by photographer during sessions.
- ***Any props, clothing, furniture or other objects used for a photo shoot must be removed at the end of the session. A \$15 clean-up fee will be charged if items remain.**
- Use care and caution around animals, moving vehicles, and landscaping. Please adhere to all safety advisories surrounding animal pens and tractor lanes.
- All pets must remain on a leash at all times. Waste must be removed and disposed of properly. Waste bags are provided at the greeting station for this purpose.
- No public area may be closed or blocked to customers during regular business hours during a session.
- Every possible effort will be made to accommodate re-scheduling a session due to a weather event. Only session dates listed above are available for rescheduling. Please contact office for any date changes.
- Any activity requiring an outside vendor will require prior notification and approval.
