

2020 PHOTOGRAPHY POLICY

FEES (Per Photographer)

- 1 hour: \$100
- 2 hours: \$150
- 3 hours: \$175
- 4 hours: \$200
- 5 hours: \$225
- 6 hours & up*: \$250

*Please confirm arrival and departure time when booking sessions longer than 6 hours.

DEPOSIT

A **50% deposit** is required for all photography appointments and is due at time of [online booking](#). Remainder of balance is due upon arrival day of session. Remaining balance will be charged to the credit card on file.

RESCHEDULING/CANCELLATIONS

- Booked sessions must be rescheduled or cancelled online **5 days** in advance to receive a refund of initial 50% deposit.
- Cancellations made within 5 days of booked session will forfeit the initial 50% deposit.
- Due to high demand, no-shows on day and time of booked session will be charged **100% of the full session fee** for time booked.
- Should Spring Creek Growers staff need to cancel sessions due to inclement weather, emergency, etc. every effort will be made to reschedule those sessions. If another date is unable to be scheduled, all deposits will be refunded in full.

All dates listed in red take place during normal Christmas tree farm retail hours. Please be aware that other customers will be onsite.

We recommend beginning your final client's photos no later than 1 hour before closing time. Please allow time for set-up and take-down when scheduling sessions/clients.

Daylight Savings time goes into effect November 1st and sundown is approximately 5:30-5:40pm.

2020 PROFESSIONAL PHOTOGRAPHY POLICY

RESERVATIONS: All photography performed at Spring Creek Growers must have an advance and approved reservation prior to any photos being taken. Appointments must be booked through: <https://springcreekgrowers.acuityscheduling.com> with a 50% deposit fee required. By scheduling a session through our online booking system, you hereby agree to all terms and conditions listed within this policy.

CHECK IN POLICY: upon arrival, all photographers must check in PRIOR to setting up. You will be issued a lanyard which you must return upon departure. Check-in will be via text message, however, you have to be present at the farm office, located behind the farmhouse/gift shop when texting. Lanyards will be accessed at that location as well. **The credit card you entered for deposit for your session will be the card charged for your balance due. We will not be able to take cash or manually process your payment. Please make sure that the card on file with us is the one to complete the reservation.** Session time begins upon check-in and ends upon check-out. Overage times greater than 15 minutes will be charged additional fees. We are not responsible for clients that may cancel or arrive late.

COVID-19 policies: Spring Creek Growers will follow CDC, Texas and Montgomery County government policies regarding COVID-19 health standards. This may include the wearing of facial masks and social distancing. Spring Creek Growers will have available hand sanitizer or hand washing stations. Masks will not be provided so if required, you and your clients will need to provide your own masks. Please be prepared to adhere to the current policies set forth by **Montgomery** County. These guidelines are to ensure your safety, the safety of your clients and the safety of our employees.

Prior to Nov. 21, 2020, the farm is NOT OPEN to the public. We are only open for professional photography sessions. Please advise your clients that gift shop, treehouse, games area and farm animals are not available prior to our opening day. Clients should be encouraged to depart the farm as soon as their photo session is completed.

Multiple photographers will be onsite on days we schedule photography. Please be professional and courteous and again, social distancing policies may be in effect for our county.

A farm map will be provided to you for planning purposes and you are encouraged to distribute to your clients. Spring Creek Growers staff is not responsible for directing clients to your photo shoot location. Please be sure that your clients have your contact information so that they can find you once they arrive.

Vehicles are not allowed in the Christmas tree fields under any circumstances. All props, furniture, etc. must be carried to your location. Artificial snow or colorants are not permitted on the trees. Non-permanent decorations are allowed but must be removed at the end of the session. A \$15 clean-up fee will be charged if items remain.

No public area may be closed or blocked to customers during regular business hours. **DO NOT BLOCK HAYRIDE LANES DURING NORMAL BUSINESS HOURS!** Use care and caution around animals, moving vehicles and landscaping. Please adhere to all safety advisories surrounding animal pens and tractor lanes.

All children under the age of 14 must always be closely accompanied by an adult.

Well-behaved dogs are welcome on the farm but must always remain on a leash. Waste must be removed and disposed of properly.

Spring Creek Growers is a fully operating farmstead. Please take into consideration weather and the natural environment as you and your clients prepare for your visit with us. Boots or closed-toe shoes are highly recommended. Dress for the weather and for the outdoors.

DEPOSITS: 50% deposit is required to make your session reservation. Again, please make sure that the credit card on file is the one to complete the reservation upon your arrival.

The photographer and all photographer's clients will hold harmless Spring Creek Growers for any injuries sustained during photography sessions and is not responsible for injuries that may occur from poses or requests by photographer during sessions. Spring Creek Growers reserves the right to prohibit any business disruptions to daily operations or to regular customers due to photography sessions. If any fixed
