2025 PHOTOGRAPHY POLICY

FEES (Per Photographer)

1 hour: \$210

2 hours: \$280 (=\$140 per hr)

3 hours: \$390 (=\$130 per hr)

4 hours: \$480 (=\$120 per hr)

Payment

Full payment is due for all photography appointments at time of <u>online booking</u>.

RESCHEDULING/CANCELLATIONS

- Booked sessions may be cancelled by phone or email <u>30 days or more</u> in advance to receive a full refund.
- Cancellations made between <u>29 days</u> <u>and 2 days</u> of booked session will be eligible for a 50% refund.
- No refunds will be issued for cancellations within 48 hours of booked appointment time.
- Reservations are not able to be reduced in length of time booked. No refund will be given for unused time.
- Reservation length increases are allowed by request and can by done only if space allows.
- Due to high demand, no-shows on day and time of booked session are not eligible for 50% refund.
- Should Spring Creek Growers staff need to cancel sessions due to inclement weather, emergency, etc. every effort will be made to reschedule those sessions on one of our rain dates.

2025 PROFESSIONAL PHOTOGRAPHY POLICY

RESERVATIONS: All photography performed at Spring Creek Growers must have an advance and approved reservation prior to any photos being taken. Appointments must be booked through: https://springcreekgrowers.acuityscheduling.com with a payment in full required. By scheduling a session through our online booking system, you hereby agree to all terms and conditions listed within this policy.

CHECK IN POLICY: upon arrival, all photographers must check in PRIOR to setting up. Check-in will be at the farmhouse/gift shop. You will be issued a lanyard which you must return upon departure. Please note: session time begins upon check-in and ends upon check-out. Overage times greater than 15 minutes will be charged additional fees to the credit card on file. We are not responsible for clients that may cancel or arrive late.

CANCELATION POLICY: Booked sessions may be cancelled by phone or email <u>30 days or more</u> in advance to receive a full refund. Cancellations made between <u>29 days and 2 days</u> of booked session will be eligible for a 50% refund. <u>No refunds</u> will be issued for cancellations within <u>48 hours</u> of booked appointment time.

Prior to Nov. 22, 2025, the farm is NOT OPEN to the public. We are only open for professional photography sessions. Please advise your clients that gift shop, treehouse, games area and farm animals are not available prior to our opening day. Clients should be instructed to depart the farm as soon as their photo session is completed.

Multiple photographers will be onsite on days we schedule photography. Please be professional and courteous. You are allowed a maximum of 2 set locations with props.

A farm map will be provided to you for planning purposes, and you are encouraged to distribute to your clients. Spring Creek Growers staff is not responsible for directing clients to your photo shoot location. Please be sure that your clients have your contact information so that they can find you once they arrive.

Vehicles are not allowed in the Christmas tree fields under any circumstances. All props, furniture, etc. must me carried to your location. Artificial snow or colorants are not permitted on the trees. Non-permanent decorations are allowed but must be removed at the end of the session. A \$15 clean-up fee will be charged if items remain.

No public area may be closed or blocked to customers during regular business hours. DO NOT BLOCK HAYRIDE LANES DURING NORMAL BUSINESS HOURS! Use care and caution around animals, moving vehicles, and landscaping. Please adhere to all safety advisories surrounding animal pens and tractor lanes.

All children under the age of 14 must always be closely accompanied by an adult.

Well-behaved dogs are welcome on the farm but must always remain on a leash. Waste must be removed and disposed of properly.

Spring Creek Growers is a fully operating farmstead. Please take into consideration the weather and the natural environment as you and your clients prepare for your visit with us. Boots or closed-toe shoes are highly recommended. Dress for the weather and for the outdoors.

Full payment is due upon booking your session.

The photographer and all photographers' clients will hold harmless Spring Creek Growers for any injuries sustained during photography sessions, and is not responsible for injuries that may occur from poses or requests by the photographer during sessions. Spring Creek Growers reserves the right to prohibit any business disruptions to daily operations or to regular customers due to photography sessions. If any fixed or temporary objects are moved or damaged during photography, the photographer will be held responsible for replacement and/or payment. Spring Creek Growers also reserves the right to prohibit inappropriate attire on premises at any time.
