2026 PROFESSIONAL PHOTOGRAPHY POLICY

FALL INTRODUCTORY PHOTOGRAPHY SESSION - NEW FOR 2026

Spring Creek Growers is excited to introduce Fall Photography Sessions for the 2026 season!

Fall Session Dates: October 1, 2026 - October 29, 2026

Special introductory pricing is available **for the 2026 Fall Photography Season only** and is subject to change in future seasons.

During Fall Photography Sessions, only designated areas of the farm will be open for photography. The remainder of the farm, including the Christmas tree fields, will be closed while our team prepares the trees and property for the Christmas season. Fall props and photography backdrops will be provided by Spring Creek Growers. **Outside props will not be permitted during Fall Photography Sessions.**

Space is limited and Seasonal Fall prop locations are available on a first-come, first-served basis upon arrival. Individual backdrop locations may be occupied for a maximum of 30 minutes to allow all photographers the opportunity to utilize each location.

RESERVATIONS

All photography performed at Spring Creek Growers must have an advance, approved reservation prior to any photos being taken. Appointments must be booked through our online scheduling system with payment due in full at the time of booking. By scheduling a session through our online booking system, you agree to all terms and conditions outlined in this Photography Policy.

CHECK-IN POLICY

Upon arrival, **all photographers (not clients)** must check in at the Farmhouse/Gift Shop before entering the farm or setting up. As part of our safety procedures, photographers are required to leave a valid Texas **Driver License (TDL)** or other government-issued photo ID at check-in. Your ID will be securely held and returned when you check out at the conclusion of your session. This allows Spring Creek Growers to account for everyone on the property and ensure all photographers and clients have safely exited the farm. Photographers will be issued a Spring Creek Growers lanyard upon check-in. **The lanyard must be always worn and visible while on the farm** so staff can easily identify photographers from clients. The lanyard must be returned upon departure. Upon arrival **only photographers** may enter the farm early for setup. Early entry is limited to 15 minutes prior to the scheduled session time, including check-in. Clients may not enter the farm until the scheduled session time. **Photography sessions begin at the scheduled reservation time and end at the scheduled end time. We are not responsible for clients who arrive late or cancel their appointments.** Photographers are responsible for removing all props and equipment and **ensuring their clients have exited the farm.** Photographers and clients must completely vacate the property and check out no later than 15 minutes after the scheduled session end time.

Overages exceeding 15 minutes will be subject to additional charges billed to the credit card on file for an additional 1 hour session with no time added to previously scheduled session(s).

CANCELLATION POLICY

Booked sessions may be canceled by phone or email **30 days or more** before the scheduled session to receive a full refund. Cancellations made **29 days to 2 days before** the scheduled session are eligible for a 50% refund. **No refunds will be issued for cancellations made within 48 hours of the scheduled appointment.**

FARM ACCESS

Prior to the official Christmas season opening, the farm is **not open to the public**. Professional photography sessions are the only permitted visits during this time. Please advise your clients that the Gift Shop, Treehouse, Games Area, and Farm Animals are not available prior to opening day unless otherwise specified by Spring Creek Growers. **Clients should depart the farm promptly upon completion of their photography session.**

PHOTOGRAPHY LOCATIONS

Multiple photographers may be scheduled on the same day. Please be professional and courteous to fellow photographers and their clients. **Photographers are permitted a maximum of two photography locations with props during their reserved session. Photography setups may not occupy more than two rows of Christmas trees in any one location.** Photography locations are available on a **first-come, first-served basis**. Spring Creek Growers cannot guarantee exclusive use of any specific location or backdrop. Please be respectful of other photographers and their clients. Do not interrupt another session, move another photographer's props, or enter an active photography area. A farm map will be provided to assist with planning. Spring Creek Growers staff is not responsible for directing clients to your photography location. Please ensure your clients have your contact information before they arrive.

VEHICLES & PROPS

Vehicles are not permitted in the Christmas tree fields under any circumstances. All props, furniture, and equipment must be carried to the photography location. Artificial snow, spray colorants, glitter, confetti, or any material that may damage the farm or trees is prohibited. Temporary decorations are permitted during Christmas photography sessions but must be removed immediately following the session. A **\$15 cleanup fee** will be charged for any items left behind.

TREE PROTECTION POLICY

Spring Creek Growers is a working Christmas tree farm, and our trees are our most valuable crop. The following are prohibited:

Climbing trees, hanging from branches, Pulling or bending branches, tying decorations directly to trees, Moving or altering trees, Placing heavy props against trees.

Any damage that causes a tree to require pruning, treatment, reshaping, or any other alteration before Christmas tree harvest season will result in a Tree Damage Fee. The fee will be determined based on the extent of the damage, treatment required, and/or the value of the damaged tree.

DURING BUSINESS HOURS

Public areas may not be blocked or closed to customers during regular business hours. **Do not block hayride lanes** during business hours. Please use caution around farm animals, moving vehicles, landscaping, tractor lanes, and uneven terrain. Follow all posted safety signs and directions from Spring Creek Growers staff.

CHILDREN

All children under the age of **14 must** always be closely accompanied by a responsible adult.

PETS

Well-behaved dogs are welcome but must always remain on a leash. Owners are responsible for cleaning up after their pets.

The photographer and all clients agree to hold harmless Spring Creek Growers, its owners, employees, and representatives from any injuries sustained during photography sessions. Spring Creek Growers is not responsible for injuries resulting from poses, props, or photographer-directed activities. Photographers are financially responsible for any damage to farm property, buildings, trees, landscaping, equipment, or temporary displays. Spring Creek Growers reserves the right to prohibit any activity, attire, or photography session that disrupts farm operations or the experience of other guests.
